Your software is both flexible and highly adaptable and it provides you with everything you need to protect your software and prevent it from being pirated.

It can help small software businesses grow into large ones, and it automates a very important part of the process.

2 Script Installation

2.1 System Requirements

PHPMyLicense will run on most Unix/Linux servers running PHP 5.x with MySQL 5.x
It is simple to setup and customise according to your needs.

2.2 Installation

The first thing you need to do is create a MySQL database and a user and assign all permissions to that user.


Next, you need to create a folder on your domain, and make that folder writable. You then need to upload the contents of your PHPMyLicense zip file to that folder.

Once you have done this you need to change the permissions of the resources/obfuscate sub-folder and also the permissions of the resources/backups sub-folder to `chmod 777`

Next, using your web browser simply go to your software folder and begin the Setup process. If you have uploaded the software to a folder named "phpmylicense" you would open your web browser here:

<http://yourdomainname/phpmylicense/>

When you do this the setup utility will automatically run and you will see the following:

There are 3 tabs giving access to each part of the licensing system.

The licenses tab lets you see a list of the licences that have been created automatically on PayPal checkout as well as any that you have created manually.

A license can be deactivated by clicking the red button marked “Active”. When you do this it goes grey and says “Disabled”.

A license can be re-activated by clicking the grey button marked “Disabled”. When you do this it goes red again and says “Active”.

You can also edit and delete these license keys using the icons provided.

3.2 New License

Whenever you need to manually create a new license key you can click the “New License” tab and the following page will appear:

When that file is opened in a web browser it will display the following warning, unless the domain has been issued with a license key:

3.5 Validation Details

You can view details of every license validation request from every domain that is using your scripts on the View Details tab. These include domains that have a valid license key, as well as invalid requests from domains that are not yet licensed.

You can see each product's price, whether or not they are currently available to purchase using the shopping cart, the currency used and the date the product was created.



4.2 Add a Product

This is the page that you use to create your products.

You need to enter a product code and full name, the product's price and whether it should be made available for purchase through the shopping cart. You can also create test products and use them in PayPal's sandbox mode.

You can create products with a once-off purchase price or products that can be made available as a subscription. You also need to enter a currency using the correct international currency code (eg: US Dollars should be entered as USD and not simply as \$. Likewise Euro is entered as EUR and British pounds as GBP and not £).

Next, you need to enter your PayPal email address to which payments should be sent on checkout and the download URL of your protected file. The download URL should use the local path and should be located in a folder of your domain or a sub-folder of your PHPMYLicense software itself. You should only enter the folder name and filename and not include "http://"

Here is an example: downloadfoldername/filename.zip

Whenever a customer pays using the shopping cart and PayPal; admin will be emailed a copy of the transaction. Also, a license key will be automatically created for the purchaser.

4.3 View Orders

This tab shows you a list of all orders made using your shopping cart. You can also view transactions that have been refunded and those that have been charged back.

Whenever you make a refund to a customer, or if they cancel a subscription, or if they charge back the transaction; their license key for that product will be automatically disabled, although you can re-activate it again if required.

Subscriptions that are cancelled will have their license key remain Active until the end of the current subscription period. Once that period has elapsed, their license key will be automatically disabled, although you will be able to re-activate it again if required.

5 Script Encoder

5.1 Encode a Single File

To encode a single file, you just need to paste its contents into the window shown below and click the Obfuscate button. The script will be encoded and you can copy the encoded results from this window into a file with the same name.


5.2 Encode Multiple Files

To encode a number of files at the same time you can use the Encode Multiple Files utility. As soon as you upload the files obfuscation commences and you can see its status.

When you select “Download Files” the encoded files you uploaded will be downloaded to your computer as a zip file.

You can then safely delete the files from the server, freeing up space for more files to be obfuscated.

6 System Settings

6.1 General Settings

The General Settings tab allows you to enable license pre-expiry email notifications to go out to customers who are near the end of their license period.

Enable license pre-expiry notifications?
Enabling this will allow the cron job to send emails to users when they are reaching the end of their license.

Automatically set-up invalid licenses?
This setting will automatically setup licenses that are returned from the server as invalid. The customers domain and product is captured at the time of the request, although we are unable to get an email address for them.

Log all license requests?
Enabling this will set the system to log all license requests, which can be viewed under the "view validation requests" section.

Log all outgoing emails?
Enabling this will set the system to log emails that are sent from the system.

Send all emails from

This field is what the system will use as the from address when sending emails.

Pagination row limiter

Set the limit of rows to be returned on all database grid views.


It's also possible to automatically setup license keys for every domain that runs your scripts, although you may not wish to do this! However, if you do, you will always be able to remotely disable any license whenever you wish.

You can also enable or disable logging of validation requests. This affects the display of Validation Requests in the License Validation area of the page which is always visible no matter where you are in the system.

Finally, you can enter the email address that should be used when sending email alerts from the system to users, as well as setting how many rows of data should display in lists and reports.

6.2 System Backup

This tab enables you to make a backup of your MySQL database whenever you wish. Simply, select Generate a New Backup to immediately create a backup. You can then download a copy by clicking the Download link. You can also delete backups whenever you need.






